

SCHOOL BOARD MINUTES

- (1) The Board of School Directors of the Lebanon School District met as a committee-of-the-whole on Monday, September 9, 2019, at 7:00 p.m. in the board conference room of the senior high school as advertised in the Daily News on December 8, 2018.
- (2) Vice-President Deb Bowman called the meeting to order at 7:00 p.m.
- (3) On roll call by the secretary, the following board members were present: Mrs. Debra L. Bowman, Mrs. Ashley Cessna, Ms. Heather Eggert, Ms. Tracy Johnsen, Mrs. Rose Marie R.
